

## INFORMATION CONCERNING THE HANDLING OF PERSONAL DATA provided pursuant to and for the purposes of Art. 13 of the European General Data Protection Regulation EU 2016/679 or GDPR

In accordance with applicable privacy laws (EU Regulations n. 679, 2016), we would like to take this opportunity to inform you that your personal information will be processed in an ethical and transparent manner, only for lawful purposes, and in a manner that safeguards your privacy and your rights.

According to the law, this treatment will be based on principles of fairness, legality and transparency and protection of your privacy and your rights.

According to Article 13 of the law. n.196 / 2003, therefore, we provide the following information:

## Purposes for which the data are intended

⇒ The personal data provided will be stored, consulted and used in relation to what is strictly necessary for the purpose of carrying out the ordinary commercial / administrative / accounting activity of the Company.

Likewise, all the data communicated by the interested subjects, are treated exclusively for fulfillments connected to the economic activity of the company, in particular:

- $\Rightarrow$  for insertion in the databases in the company computer / paper databases
- $\Rightarrow$  for the issuance of invoices and credit notes
- $\Rightarrow$  for the keeping of ordinary accounting and VAT
- $\Rightarrow$  for the management of receipts and payments

## Nature of the data and consequences of refusal to reply
